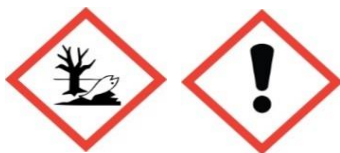

Section 4: First Aid Measures

Inhalation: Remove from exposure to fresh air. Contact a physician as necessary. Contact a physician if irritation persists.
